

Active Interplast Terms & Conditions

1. I, the participant (Participant) in any dedicated Active Interplast challenge (the Challenge) acknowledge and agree that these terms and conditions are subject to change from time to time at the discretion of Interplast Australia & New Zealand (Interplast) ABN 59 006 155 193 and without notice to the Participant.
2. I certify that I am 18 years or older, or that I am the parent/legal guardian of the Participant who is under the age of 18 years, and I have read and understood the terms and conditions of the Challenge. As a parent or legal guardian, I agree to these terms and conditions for and on behalf of the Participant.
3. I acknowledge that each event within the Challenge is subject to its own terms and conditions which I/ the Participant must adhere to.
4. I agree that by signing up to Active Interplast, I/ the Participant commits to raising a minimum of \$150 prior to participating in the Challenge.
5. I acknowledge that I/the Participant will not be entitled to any refund of donations if the Event is cancelled for any reason. I declare, as a condition of entry into the Challenge, that I/the Participant have undertaken sufficient training for the Challenge and that I am not aware of any illness, injury, physical disability or impairment which may cause injury or death during or as a consequence of Challenge participation.
6. I understand and acknowledge that there is an inherent risk in the Challenge. To the extent permitted by law, I undertake and represent that I/the Participant will not make any claims against Interplast and hereby release Interplast Australia (and its directors, officers, employees, representatives, volunteers, sponsors, contractors, subcontractors (and their respective employees) or agents) (individually and collectively, the "Released Parties") from and against any liability, claims, causes of action, suits or proceedings, including claims for costs or expenses of any nature for any loss, injury, damage of any description whatsoever (including but not limited to injury, death or property damage, and indirect or consequential damage) ("Claim") suffered in connection with [my/the Participant's] attendance and participation at the Challenge, howsoever caused, including due to any negligent or wilful acts or omissions by the Released Parties and I indemnify the Released Parties from and against all Claims (including negligence) whatsoever and howsoever caused arising as a result of or in connection with [my/the Participants] participation in the Challenge including any injury, death or property damage.
7. I agree to indemnify and keep indemnified the Indemnified Parties against all actions, suits, demands, claims, proceedings, costs, expenses, liabilities and judgements whatsoever (including without limitation for negligence, breach of contract and/or breach of statute) arising out of, in connection with, or in relation to my participation in the Event. This indemnity may be pleaded as a bar to any action, claim, demand, suit or legal proceedings. The releases and indemnities in this document continue forever and bind my heirs, executors, personal representatives and assigns.
8. I/the Participant agree to accept full responsibility to inform myself/the Participant and assess all the dangers, hazards and risks of entry in the Challenge and rely solely on my own assessment of these dangers, hazards and risks before participating in the Challenge and notwithstanding any decision thereon made by the race committee and other persons corporations and bodies involved in promoting or staging the Challenge. The decision to participate is entirely my/ the Participants own and I/they accept all risks associated with participation in the Challenge, including but not limited to loss of life and/or any injury including without limitation any permanent injury.
9. I acknowledge that my/the Participant's participation in the event is at my/their own risk. I am solely responsible for taking appropriate measures to prevent injury or avoiding any other risks associated with my participation. I accept that should I/the Participant require medical assistance at the event due to participation, such as transportation to a hospital, I/the Participant will be responsible for these costs.
10. I understand that should my/the Participant's contact details change after my registration is completed; it is my responsibility to notify the Active Interplast administrators.
11. Transfers of registration are the responsibility of the Participant and must be made according to the Event's specific terms and conditions.
12. I understand that during the Challenge or related activities I/the participant may be photographed or filmed. I agree to allow my/the Participant's photography, video or film likeness to be used for any legitimate purpose (including social media platforms, our website and newsletters) by Interplast. The same is also agreed to the use of any testimonial given
