- 1. I, the participant (Participant) in any dedicated Active Interplast challenge (the Challenge) acknowledge and agree that these terms and conditions are subject to change from time to time at the discretion of Interplast Australia & New Zealand (Interplast) ABN 59 006 155 193 and without notice to the Participant.
- 2. I certify that I am 18 years or older, or that I am the parent/legal guardian of the Participant who is under the age of 18 years, and I have read and understood the terms and conditions of the Challenge. As a parent or legal guardian, I agree to these terms and conditions for and on behalf of the Participant.
- 3. I acknowledge that each event within the Challenge is subject to its own terms and conditions which I/ the Participant must adhere to.
- 4. I agree that by signing up to Active Interplast, I/ the Participant commits to raising a minimum of \$150 prior to participating in the Challenge.
- 5. I acknowledge that I/the Participant will not be entitled to any refund of donations if the Event is cancelled for any reason. I declare, as a condition of entry into the Challenge, that I/the Participant have undertaken sufficient training for the Challenge and that I am not aware of any illness, injury, physical disability or impairment which may cause injury or death during or as a consequence of Challenge participation.
